- **Minimum Time in Service:**

resident of New York City, or become a resident within a specified time after appointment (usually 90 days).

These prerequisites ensure that only seasoned officers with a solid foundation in correctional work are eligible to compete for leadership roles.

### **EXAM CONTENT AND FORMAT**

rights under the Eighth and Fourteenth Amendments, as well as local and state laws, is essential.

## Question Format

Most questions are multiple-choice with four or five options. You will read a brief scenario or statement and select the best answer. Some exams also include reading comprehension passages related to policies or legal texts. There are no essay questions in the standard written exam, but you will need strong analytical skills to choose the most appropriate response, as often multiple answers may seem plausible.

## **CORRECTIONS CAPTAIN EXAM**

Preparation is the single most important factor in success. The exam is competitive, and the number of candidates who pass may be limited to those who score highest. Here are proven strategies to help you prepare effectively.

### Obtain the Official Study Materials

The NYC DOC and DCAS typically provide a list of reference materials for the exam. This often includes the DOC's

“Operations, Policies, Procedures, and Regulations for New York City Correction Officers,” and any specific study guides issued for the promotion. Obtain these documents early. Read them thoroughly, not once but multiple times. Pay close attention to procedures you may not encounter daily, such as outbreak protocols or hostage negotiation guidelines.

### Form a Study Group

Studying with colleagues who are also preparing for the exam can be highly effective. You can quiz each other, discuss interpretations of policies, and share notes. Study groups also help you

## WHAT TO EXPECT ON EXAM DAY

---

The exam is usually held at a DCAS testing center or a large venue like a convention hall. You will need to bring your photo ID, exam admission letter,

and an approved calculator if the exam includes arithmetic (though most corrections exams do not). Arrive early, as seating is assigned.

- **Time Limit:** The exam typically lasts 3 to 4 hours. Manage your time wisely. Do not get stuck on a single question.
- **Answer Sheet:** You will use a Scantron sheet. Bring a few No. 2 pencils and a good eraser.
- **Test Environment:** The room is quiet and monitored. Follow all instructions. Any attempt to cheat or disrupt the test will result in disqualification.

## **BETOND THE EXAM: THE**

---

After you take the **Nyc Corrections Captain Exam**, your raw score (number of correct answers) is converted to a scaled score. You must achieve a passing score, which is usually 70% or higher. However, simply passing is not enough. Candidates are ranked by score on an eligibility list. The DOC may promote from the top of this list, often selecting the highest-scoring candidates first. Additional points may be awarded for seniority, education, or military service (veterans' preference). The eligibility list remains active for up to four years, though promotions depend on departmental needs.

## **APPOINTMENT PROCESS**

---

Passing the exam is a major achievement, but it is only the first step. Candidates who rank high on the list will undergo an interview, a background check, and possibly a medical or psychological evaluation. Some candidates may also be required to attend an assessment center where they demonstrate leadership skills in simulated scenarios. Once all checks are cleared, the DOC will appoint you as a Captain on a probationary basis. The probation period is typically one year, during which your performance is closely evaluated.

## How often is the Nyc Corrections Captain Exam offered?

The exam is not held every year. It is typically offered every two to four years, depending on the DOC's hiring needs. Keep an eye on DCAS announcements and official DOC bulletins.

## Can I take the exam if I am on probation as a new officer?

No. You must have permanent civil service status as a Correction Officer. This usually requires completing your initial probationary period of 12 to 24 months.
