Capitalization Rate (Cap Rate)

The cap rate is arguably the most important metric in CRE. It measures the rate of return on a property based on its net operating income (NOI). The formula is simple: $\text{Cap Rate} = \text{NOI} / \text{Property Value}$. A higher cap rate generally indicates a higher potential return but also higher risk. For example, a property in a stable downtown area might have a 6% cap rate, while a riskier

property in a secondary market might have a 10% cap rate.

Net Operating Income (NOI)

NOI is the total income a property generates minus all operating expenses (maintenance, property management, insurance, utilities, and taxes). It does not include debt payments or capital expenditures. NOI is the foundation for calculating cap rates and determining property value.

Cash-on-Cash Return

This measures the annual return on the actual cash you invested. If you put down \$100,000 and receive \$12,000 in cash flow per year, your cash-on-cash return is 12%. This metric is especially useful when comparing deals that use different amounts of leverage.

Loan-to-Value Ratio (LTV)

LTV compares the loan amount to the appraised value of the property. Most commercial lenders require an LTV of 65% to 75%. A lower LTV means you have more equity and less risk, but it also requires a larger down payment.

Due Diligence

This is the investigation period after you go under contract. During due diligence, you inspect the property, review leases, confirm income and expenses, check zoning, and assess environmental risks. This is your chance to back out if something is wrong.
