4. The Full Disclosure Principle

5. The Objectivity

According to the **objectivity principle**, accounting entries should be based on objective evidence, such as purchase receipts, bank statements, or contracts, rather than subjective opinions. This keeps financial reporting free from bias and manipulation. For instance, an accountant cannot simply guess the value of an asset; they must use verifiable documents. This principle underpins the credibility of the entire accounting profession. Without objectivity, financial statements would lose their reliability.

6. The Consisten cy Principle

The **consistency principle** requires that businesses apply the same accounting methods from one period to the next. If a company changes depreciation methods or revenue recognition policies, it must disclose the change and explain the impact. This allows stakeholders to compare financial results across time. For example, if a firm switches from FIFO to LIFO inventory valuation, it must show the effect on net income. Consistency is

7. The Materiality Principle

For example, if a company is sued, it should record a loss if the loss is probable and can be estimated, but it should not record a potential gain until the gain is realized. This principle prevents over-optimistic reporting and protects investors from inflated expectations. It is a key **fundamental accounting principle** when dealing with estimates and contingencies.

9. The Going

Concern Principle

The **going concern principle** assumes that a business will continue to operate indefinitely unless there is evidence to the contrary. This assumption justifies using historical cost depreciation and amortization rather than liquidation values. If a company is expected to go bankrupt in the near future, the going concern assumption no longer applies, and assets must be recorded at their liquidation value. This principle influences issues like goodwill impairment and long-term debt classification. It is a deeply rooted

10. The Economic Entity Principle

The **economic entity principle** separates the business's financial affairs from those of its owners or other entities. Personal assets and expenses of the owner must not be mixed with company transactions. This principle ensures that financial statements reflect only the business's activities. For example, a sole proprietor must have a separate bank account

for the business and record business income and expenses separately. This separation is crucial for accurate tax reporting and legal protection.

11. The Monetary Unit Principle

The **monetary unit principle** states that only transactions that can be expressed in monetary terms should be recorded in the accounting books. This means that non-financial factors, such as employee morale or brand reputation, are not reflected in the financial statements unless they can be measured in currency.

It also assumes that the purchasing power of the currency is stable over time, which is why inflation adjustments are not typically made in standard accounting. This principle simplifies recording but also means that some valuable intangible aspects of a business remain off the balance sheet.

12. The Time Period Principle

The **time period principle** divides the life of a business into regular intervals, such as months, quarters, or years, for reporting purposes. This allows

stakeholders to evaluate performance on a timely basis. Without this principle, companies would only report when they shut down, which is impractical. The time period principle works hand-in-hand with revenue recognition and matching to ensure that each period's financial statements are complete and accurate. It is a fundamental **accounting principle** that enables periodic performance reviews.

THE ACCOUNTING EQUATION AND DOUBLE-ENTRY BOOKKEEPING
