People who spend more time in public spaces at night, who associate with high-risk individuals, or who engage in activities like heavy drinking are more likely to become crime victims. This theory explains why young, single males have the highest victimization rates for violent crime.

The practical application of lifestyle exposure theory is widespread. Crime prevention through environmental design (CPTED) uses these insights to improve lighting, increase surveillance, and design safer public spaces. Personal safety campaigns also use lifestyle exposure principles to encourage people to modify their routines and reduce risk.

### Routine Activity Theory

Closely related to lifestyle exposure, routine activity theory was introduced by Lawrence Cohen and Marcus Felson. It argues that for a crime to occur, three elements must converge in time and space: a motivated offender, a suitable target, and the absence of a capable guardian. Notice that the victim is not blamed; rather, the focus is on the circumstances that make victimization possible.

This theory is extremely influential in modern criminology and policing. It underpins community policing initiatives, neighborhood watch programs, and targeted patrols in high-crime areas.
