Parentheses

Variables on Both Sides

To truly master the concept, a student must be able to handle equations where y

appears on both sides of the equals sign. For instance, $2y + 3x = y - 5$. The student must move all terms containing y to one side and all other terms to the other. This requires careful attention to signs and is often a stumbling block for beginners.

STEP-BY-STEP STRATEGIES FOR SUCCESS

COMMON MISTAKES TO WATCH FOR

Even diligent students make errors. A well-

Sign Errors

Dividing Incorrectly

Confusing the Order of Operation S

When isolating y , students sometimes try to undo multiplication before addition. The order of inverse operations is the reverse of the order of operations. Since multiplication and division come before addition and subtraction in PEMDAS, you should undo addition and subtraction first when

solving an equation.

HOW TO USE A SOLVING EQUATIONS FOR Y WORKSHEET EFFECTIVELY
