REAL CLASSROOM EXAMPLE: A GRADE 7 UNIT ON “THE POWER OF ONE”

To bring the description to life, consider a typical unit from **Common Core Code X** Grade 7 titled “The Power of One.” The essential question is: “Can one person make a difference?” The anchor text is an excerpt from *I Am Malala* by Malala Yousafzai. Students

read the excerpt closely, analyzing how Malala uses personal narrative to argue for educational rights.

By the end of the unit, students have not only improved their reading comprehension and writing skills but have also grappled with a real-world issue in a personally meaningful way—exactly the kind of learning that

Common Core Code X aims to foster.
