BUSINESS CASUAL  
IS YOUR SAFE  
HARBOR**

The single best piece of advice for most applicants is to aim for business casual attire. This dress code strikes a perfect balance between professionalism and comfort. It is formal enough to show respect but not so stiff that you feel awkward or uncomfortable during what can be a lengthy waiting period and interview.

Business casual for a citizenship interview generally means clean, pressed, and well-

fitting clothing that you might wear to a respectable office job or a nice restaurant. It avoids the extremes of both formal business suits and casual weekend wear. When you research what to wear for citizenship interview, business casual is the most frequently recommended standard, and for good reason. It is universally appropriate, reduces the risk of being underdressed, and allows your personality and seriousness to shine through without the distraction of inappropriate attire.

# Casual for Men

For men, business casual is straightforward and comfortable. A excellent choice is a pair of khakis or dark-colored dress slacks paired with a collared shirt. - **Shoes:** Loafers, oxfords, or clean leather sneakers (in neutral colors).
- **Avoid:** T-shirts with graphics or slogans, shorts, athletic wear, baseball caps, and overly casual sneakers.

# Business Casual for Women

Women have a wider range of acceptable options, which can sometimes make the decision harder. The key is to choose something professional, modest, and comfortable. A blouse paired with dress pants or a professional skirt is a classic and reliable choice. A simple dress, paired with a cardigan or blazer, also works beautifully. If you prefer a more modern look, a nice sweater with tailored trousers is perfectly acceptable.

- **Tops:** Blouses,

button-down shirts, sweaters, or tasteful shells. Avoid anything too low-cut, sheer, or revealing.

- **Bottoms:** Dress pants, a professional skirt (at knee-length or longer), or tailored trousers. Avoid extremely tight leggings or yoga pants.
- **Dresses:** A simple, professional dress is an excellent one-piece solution. Pair it with a blazer or cardigan for a polished look.
- **Shoes:** Flats, low heels, loafers, or professional boots. Avoid very high heels, noisy clogs, or flip-

flops.

- **Avoid:** Casual sundresses, ripped jeans, revealing clothing, excessive cleavage, and overly casual sandals.

### **WHAT TO ABSOLUTELY AVOID WEARING**

---

Equally important as knowing what to wear is knowing what to avoid. Some clothing choices can actively harm your chances of making a positive impression. This is not about being judged unfairly, but about understanding the formal context of the interview. ## Clothing

Also, avoid overly flashy jewelry, extremely bright colors, or loud patterns that might distract the officer.

# Uncomfor table or Impractic al Shoes

You may be waiting for a long time in a lobby before your interview. Avoid brand-new shoes that are not broken in or extremely high heels that will cause you pain and make you look uncomfortable. You want to be able to stand and sit with ease, so choose sensible, comfortable professional footwear.

While not strictly clothing, strong perfumes, colognes, or scented lotions can be a problem. Many government offices have strict policies about fragrances due to allergies and sensitivities. It is best to wear little to no scent. You want to be remembered for your poise and answers, not for an overpowering perfume.

## **GROOMING AND ACCESSORIES: COMPLETING THE PROFESSIONAL LOOK**

---

Your clothing is just one part of the equation. Grooming and accessories also

contribute significantly to the overall impression. The goal is to look clean, well-maintained, and put-together.

## Personal Grooming

Ensure your hair is clean and neatly styled. For men, facial hair should be neatly trimmed or cleanly shaven. Nails should be clean and trimmed. Minimal, natural-looking makeup is appropriate for women. The overall aim is to look healthy, clean, and professional. Good grooming reinforces the message that you are serious and prepared.

# Accessories

Keep accessories simple and professional. A classic watch is always a good choice. Jewelry should be minimal and not distracting. If you carry a handbag, choose a professional tote or bag rather than a casual backpack or beach bag. For those who wear glasses, make sure they are clean. The focus should remain on your face and your responses, not on your accessories.

## CULTURAL AND RELIGIOUS CONSIDERATIONS

---

USCIS officers are trained to be respectful of cultural and religious diversity. The

guidelines for what to wear for citizenship interview are flexible enough to accommodate various traditions. If your religion or culture requires specific attire, such as a hijab, turban, yarmulke, or other headwear, you should absolutely wear it. These are expressions of your identity and are perfectly appropriate in a professional setting. The key is simply to ensure your attire, within your cultural norms, is neat, clean, and professional.
