Focus on Math

Real estate math questions often involve percentage, area, loan-to-value ratios, and prorations. Practice these daily. Understand formulas like:

- $\text{Commission} = \text{Sale Price} \times \text{Commission Rate}$
- $\text{Property Tax} = \text{Assessed Value} \times \text{Mill Rate}$
- $\text{Loan Amount} = \text{Purchase Price} \times \text{LTV Ratio}$
- $\text{Interest} = \text{Principal} \times \text{Rate} \times \text{Time}$

Keep a formula sheet handy during your study sessions.

Manage Your Time

Divide total time by number of questions to get a per-question average. If a question takes more than 90 seconds, flag it and move on. Return to flagged questions only if you have time. Never leave a question blank—guessing is

better.

Stay Calm and Trust Your Preparation

Test anxiety can cloud your thinking. Take deep breaths. Remind yourself that you have followed a solid study guide for real estate exam and you know the material. Skip hard questions temporarily to build momentum.

COMMON MISTAKES TO AVOID
