## Meeting Quality and Labeling

The Food and Drug Administration (FDA) has strict standards of identity for bottled water. It distinguishes between different types (spring, purified, mineral, artesian, etc.). Your product must meet the specific definition for its label. Furthermore, the FDA requires a standard nutrition facts panel, an ingredient list, and the name and address of the manufacturer, packer, or distributor. You are also required to regularly test your water for contaminants and maintain detailed records. Adhering to these standards is not just a legal requirement; it is the foundation of

consumer trust.

### **PHASE 3: SOURCING AND TREATMENT**

The quality of your product is determined by the quality of your source and the effectiveness of your treatment process. This is the heart of your operation.

## Selecting a Water Source

Your water source will define your brand. The three most common options are:

1. **Spring Water:**  
Sourced from an underground formation from which water flows naturally to the surface. This commands a premium price but requires a specific natural source and federal approval for collection.

3. **Well or Groundwater:**  
You can drill a well on your property or on a leased site. This

Investing in a high-quality treatment system is non-negotiable. It ensures product consistency and safety, which is the most important element of your brand reputation.
