# Proportion, and Dimensional Analysis

Two primary methods dominate medication calculation: ratio and proportion, and dimensional analysis. Ratio and proportion is a straightforward method that sets up a known ratio (such as the drug concentration) equal to a desired ratio (the prescribed dose over the unknown volume). For example, if a solution contains 500 mg in 250 mL, and you need to give 200 mg, you set up:  $500 \text{ mg} / 250 \text{ mL} = 200 \text{ mg} / X$

mL. Cross-multiplying gives you  $500X = 200 \times 250$ , so  $X = 100$  mL. This method is intuitive and widely used.

Dimensional analysis, on the other hand, is a more systematic approach that uses unit cancellation to arrive at the final answer. It is particularly powerful for complex, multi-step problems. For example, to calculate how many tablets to give for a 0.5 gram order when tablets are 250 mg each, you would set up:  $0.5 \text{ g} \times (1000 \text{ mg} / 1 \text{ g}) \times (1 \text{ tablet} / 250 \text{ mg}) = 2 \text{ tablets}$ . You would first note the concentration (250 mg per 1 mL), then set up:  $750 \text{ mg} / 250 \text{ mg per mL} = 3 \text{ mL}$ . These questions reinforce the importance of reading labels carefully and understanding concentration.

# Intravenous (IV) Flow Rate Calculations

IV infusion calculations are another major category in **Math For Meds Practice**

**Questions.** These problems require you to calculate the rate at which an IV solution should flow, usually expressed in milliliters per hour (mL/hr) or drops per minute (gtts/min). The prescribed dose of 300 mg falls within this range, so it is considered safe.
