## Algebra and Arithmetic

In algebra, constants appear as coefficients (like the 2 in  $2x$ ) or as constant terms (like the 7 in  $x + 7$ ). They help define polynomial expressions. For example, in the polynomial  $4x^3 - 2x^2 + 5x - 9$ , the numbers 4, -2, 5, and -9 are constants. The constant term (-9) is the value of the polynomial when  $x = 0$ .
