### THE SEMI-BLOCK FORMAT

## When to Use Semi-Block Format

## THE SIMPLIFIED FORMAT

### When to Use Simplified Format

The simplified format is best suited for internal communications, mass mailings,

or letters where a personal touch is not required. It is also useful when you do not know the recipient's name or gender, as it avoids the potential awkwardness of a generic salutation. ### THE INDENTED FORMAT
