Key Legal Requirements for Leases in North

SECURITY DEPOSIT REGULATIONS

- **Authorized Agent Disclosure:** If a property management company is involved, the landlord must identify the person authorized to manage the property and receive legal notices.

LANDLORD'S DUTY TO MAINTAIN HABITABILITY

Under North Carolina law, landlords are required to maintain the rental property in a fit and habitable condition. This includes ensuring that the property complies with applicable building and housing codes, making necessary repairs to keep the premises safe, and maintaining essential services like plumbing, heating, and electricity. - Respect the tenant's right to privacy and provide reasonable notice before entry.
- Return the security deposit within 30 days of lease termination, with itemized deductions if applicable.
- Not discriminate against tenants based on race, color, religion, sex, national origin, familial status, or disability (per the Fair Housing Act).
