- Customers who are evasive about their identity or the source of their funds

- Attempts to bribe or threaten casino staff
- Use of multiple identification documents or aliases

Effective Title 31 training for casinos emphasizes the importance of timely reporting. SARs must be filed with FinCEN within 30 days of detecting

suspicious activity, with an additional 30-day extension available under certain circumstances. Failure to file promptly can result in significant regulatory penalties.

Recordkeeping Obligations
