SEPARATION AGREEMENT

The foundation of any Ohio dissolution is a legally binding document called a separation agreement. This agreement must address every aspect of your marital life that requires legal resolution. Drafting a thorough and precise separation agreement is the single most important step in the entire process.

- **Child support:** Calculate child support according to Ohio's child support guidelines. The court must approve any deviation from the

standard calculation.

Drafting the Separation Agreement

While it is possible to draft a separation agreement without an attorney, it is generally not recommended unless your situation is very simple and you both fully understand the legal consequences.
