STRUCTURE OF THE EFQM EXCELLENCE MODEL 2013

The model is built
around nine criteria,
divided into two
groups: Enablers (five
criteria) and Results
(four criteria). The
**EFQM Excellence
Model 2013 by EFQM**
uses a weighted
scoring system, with
Enablers and Results
each representing 50%
of the total possible
points. This balance
emphasizes that
excellent processes

must lead to excellent outcomes.

Enabler Criteria (What the Organization Does)

1. **Leadership:** How leaders develop and facilitate the achievement of the mission and vision, develop values required for long-term success, and implement these through appropriate actions and behaviours.
2. **Strategy:** How the organization

implements its mission and vision by developing a stakeholder-focused strategy, supported by policies, plans, objectives, and processes.

3. **People:** How the organization manages, develops, and releases the knowledge and full potential of its people at an individual, team-based, and organization-wide level.
4. **Partnerships and Resources:** How the organization plans and manages its external partnerships and internal resources to

support its strategy and operational processes.

5. **Processes, Products and Services:** How the organization designs, manages, and improves its processes, products, and services to generate increasing value for customers and other stakeholders.

Results Criteria (What the Organizat

ion Achieves)

1. **Customer Results:**
Perceptions and performance indicators relating to customers.
2. **People Results:**
Perceptions and performance indicators relating to people (employees).
3. **Society Results:**
Perceptions and performance indicators relating to society (including environmental and community impact).
4. **Key Results:**
Financial and non-financial

outcomes that demonstrate the organization's overall performance and strategic objectives.

Each criterion is further subdivided into sub-criteria. For example, "Leadership" includes sub-criteria such as "Leaders develop the mission, vision, values, and ethical role model behaviour" and "Leaders define, monitor, review, and drive the improvement of the organization's management system."

THE RADAR LOGIC: ASSESSMENT AND SCORING

A distinctive feature of the **EFQM Excellence Model 2013 by EFQM** is the RADAR logic, which provides a

systematic approach to assessing an organization's performance. RADAR stands for:

- **Results** – Determine the results that the organization is aiming for as part of its strategy.
