The card is their primary tool for asserting this position in interactions with employers, banks, and government agencies.

Historical Background and the Roots of the Movement

Legal Analysis: Why the Moorish National Tax Exempt Card Does Not Work

From a legal standpoint, the Moorish National Tax Exempt Card has **no validity whatsoever**. Every federal court that has examined claims based on the Moorish sovereign defense, including claims of tax exemption, has dismissed them as frivolous. Official IRS and Court Stances
