Insurance: Do not cancel your commercial insurance policy until the truck is physically returned and the inspection is complete. If the truck is damaged while in your possession, you are liable.

Avoid phrases like "I might want to end the lease." Use definitive language such as "I hereby provide formal notice of termination."
