MONTHLY CASH FLOW SUMMARY

The form typically includes a section

where you calculate your net monthly cash flow by subtracting your total expenses from your total income. This figure is a key factor in determining what you can afford to pay.

The form is usually mailed to you directly by the Michigan Department of Treasury or its contracted collection agency.
