For example, when a business makes a sale on credit, it records a debit to Accounts Receivable (an asset) and a credit to Sales Revenue (which increases equity). ACCRUAL VS. CASH BASIS ACCOUNTING

Cash Basis Accounting

Accrual Basis Accounting

Accrual accounting is more complex but offers a more accurate picture of a company's financial health. Under this method, revenue is recorded when it is earned (goods or services are

provided), regardless of when cash is received. Similarly, expenses are recorded when they are incurred, regardless of when they are paid. This aligns with the matching principle, a fundamental financial accounting concept that dictates that expenses should be matched with the revenues they help generate in the same accounting period.

For example, if a landscaping company completes a job in December but does not get paid until January, accrual accounting records the revenue in December. It also records any expenses for gas, labor, or materials used for that job in December. This provides a truer representation of the company's performance for that period. Most medium to large businesses and all publicly traded companies are required to use accrual accounting under Generally Accepted Accounting Principles (GAAP).

1. **Operating Activities:** Cash generated from or used in core business operations, such as cash received from customers and cash paid to suppliers and employees.
2. **Investing Activities:** Cash used for or generated from the purchase or sale of long-term assets, such as property, plant, equipment, or investments.

3. **Financing Activities:** Cash received from or paid to investors and creditors, such as issuing stock, borrowing money, repaying loans, or paying dividends.

This statement is indispensable for understanding how a company generates and uses its cash, revealing its ability to fund operations, invest in growth, and return value to shareholders.

- **The Monetary Unit Assumption:** This principle assumes that all transactions can be recorded in a stable currency (e.g., US dollars) and that inflation or deflation is ignored for accounting purposes, unless it becomes extreme.
