The test is a standardized, multiple-choice exam that serves as the primary filter for thousands of applicants vying for a limited number of positions. Because the DSNY is one of the largest sanitation departments in the world, the competition is fierce, and a strong performance on the test is essential for moving forward in the hiring process. The exam is typically offered only once every few years, so missing an administration can mean waiting years for the next opportunity.

## Eligibility Requirements for Taking the Exam

Before you even register for the New York Sanitation Test, you must meet several baseline eligibility criteria. These requirements are non-negotiable and are strictly enforced by DCAS. First, you must be a United States citizen or have a valid permanent resident card at the time of application. Second, you must be a resident of one of the five boroughs of New York City—Manhattan, Brooklyn, Queens, The Bronx, or Staten Island—or be willing to establish residency within a specified period after appointment. Third, you must possess a valid New York State driver license at the time of appointment, although you do not necessarily need it when you apply for the test. Fourth, you must be at least 18 years old at the time of appointment. Fifth, you must have a high school diploma or a

General Equivalency Diploma (GED). Finally, you must be physically and medically capable of performing the strenuous duties of a sanitation worker, which includes heavy lifting, prolonged standing, and working in all weather conditions. Meeting these requirements does not guarantee a job, but it does allow you to sit for the examination.

## HOW TO APPLY FOR THE SANITATION TEST

The application process for the New York Sanitation Test is entirely online through the DCAS website. When the exam is announced, a filing period typically opens for a few weeks, and applications are accepted on a first-come, first-served basis, though capacity is often capped. To apply, you will need to create an account on the DCAS Online Application System (OASys). You will then search for the sanitation worker exam, complete the application form, and pay a non-refundable application fee, which is usually around \$50 to \$60. It is crucial to apply early, as the filing period can close once a certain number of applications are received. After your application is processed, you will receive an admission letter via email or through your OASys account, which will detail the date, time, and location of your exam. Keep this letter safe, as you will need to present it along with a valid, government-issued photo ID to gain entry to the test site. Additionally, be aware that the City may make changes to the application process, so always refer to the official DCAS or DSNY websites for the most current information.

## STRUCTURE AND CONTENT OF THE NEW YORK SANITATION TEST

The New York Sanitation Test is designed to evaluate core competencies that are relevant to the daily tasks of a sanitation worker. The test is not about memorizing facts about recycling rules or snow removal protocols. Instead, it focuses on foundational skills that indicate your ability to learn and perform on the job. Understanding the structure of the test is the first step toward effective preparation. The test typically consists of several distinct sections, each timed separately.

## Reading Comprehension

This section measures your ability to read and understand written passages. You will be presented with paragraphs related to safety procedures, city regulations, or operational guidelines, followed by multiple-choice questions that test your grasp of the main ideas, supporting details, and inferences. Strong reading comprehension is essential because sanitation workers must be able to follow complex instructions, read maps, and understand safety protocols. Practice reading technical documents and summarizing key points to improve in this area.

## Arithmetic and Mathematical Reasoning

Basic math skills are critical for a sanitation worker. This section includes problems involving addition, subtraction, multiplication, division, fractions, decimals, percentages, and simple ratios. You might be asked to calculate the volume of a truck, the weight of

collected refuse, or the time required to complete a route. The math is not advanced, but you must be comfortable with basic calculations without a calculator, as one is not permitted during the test. Practicing mental math and reviewing basic arithmetic concepts is highly beneficial.

## Map Reading and Spatial Orientation

Sanitation workers must be able to navigate city streets efficiently. This section tests your ability to read maps, follow directional instructions, and determine the most efficient routes. You may be shown a map of a neighborhood and asked to identify the shortest path between two points, or to determine which streets are one-way. Familiarity with the grid system of New York City streets can be helpful, but the test focuses on general map-reading skills that apply to any urban environment.

## Following Written Instructions

This portion evaluates your ability to read and carry out a set of detailed instructions accurately. You might be given a series of steps related to a collection route or a safety procedure, and you must answer questions about the correct order of operations or identify errors in the instructions. Attention to detail is paramount here. Practice by reading multi-step directions and summarizing them without missing any steps.

## Memory and Observation

Some versions of the test include a section that assesses short-term memory and observational skills. You may be shown an image or a list of items for a brief period and then asked questions about what you saw. This simulates the need for sanitation workers to quickly assess situations, remember license plates, or recall specific details about a location. Practicing memory exercises and paying close attention to your surroundings can help sharpen these skills.

### HOW TO PREPARE EFFECTIVELY FOR THE EXAM

Preparation is the key to success on the New York Sanitation Test. Because the exam is offered infrequently, you must make the most of your opportunity. Start by obtaining the official test preparation materials provided by DCAS. These materials include sample questions and a detailed description of the test format. ### WHAT TO EXPECT ON TEST DAY

The test is administered at various locations across New York City, often at public schools or community centers. You should plan to arrive at least 30 minutes early to allow time for check-in. You must bring your admission letter and a valid, government-issued photo ID, such as a driver license or passport. No electronic devices, including cell phones, smartwatches, or calculators, are allowed in the testing room. You will be provided with scratch paper and a pencil, though bringing your own pencils and erasers is a good idea. The test is timed, and you must manage your time carefully. If you get stuck on a question, move on and come back to it if time permits. Most candidates find the test challenging but fair, and those who have prepared thoroughly tend to perform well.

### UNDERSTANDING THE PHYSICAL AND MEDICAL EXAMINATIONS

Passing the written New York Sanitation Test is only the first hurdle. Candidates who achieve a high enough score are placed on an eligible list and eventually called for a physical and medical examination. The physical exam, often referred to as the physical ability test (PAT), is designed to simulate the physical demands of the job. It typically includes tasks such as lifting heavy cans, climbing in and out of a truck, walking long distances, and dragging weighted objects. You must be in excellent physical condition to pass this test. The medical exam includes vision and hearing tests, a drug screening, and a general health assessment. The DSNY has strict medical standards, and certain conditions may disqualify you. Therefore, it is wise to start a fitness regimen early and consult with a doctor if you have any health concerns.

### SCORING, RANKING, AND THE HIRING PROCESS

Your score on the New York Sanitation Test determines your rank on the civil service list. The list is established based on your score, with candidates who score higher receiving lower list numbers. Veterans and residents of New York City may receive additional credits that improve their standing. When the DSNY has job openings, they hire from the list in order of rank. The list is typically valid for four years, but the actual wait time depends on hiring needs and your position on the list. Being in the top few hundred is generally considered a strong position. Once you are called, you will undergo the physical and medical exams, a background check, and a character investigation. The entire process from test to appointment can take many months or even years, so patience and persistence are essential.
