## UNDERSTANDING THE IMM 5444 E APPLICATION FOR A PERMANENT RESIDENT CARD

fall into one of the following groups:

- **Card Renewal:** If your current Permanent Resident Card is expiring or has already expired, you need to submit a new application to renew it.
- **Lost, Stolen, or Damaged Card:** If your card has been lost, stolen, or destroyed, you must report it and then apply for a replacement using this form.
- **Change of Name:** If you have legally changed your name since

receiving your last PR card, you must apply for a new card reflecting your updated name.

- **Card Never Received:** If you became a permanent resident months ago but never received your first card, you can use this form to request a re-issuance.

It is important to note that children under 18 years of age also require their own separate applications. A parent or legal guardian must sign the application on their behalf.

## Eligibility

## Requirements: The Five-Year Residency Obligation

Before you begin filling out the **Imm 5444 E application for a Permanent Resident Card**, you must ensure you meet the Canadian residency obligation. This is a legal requirement that all permanent residents must fulfill to maintain their status. The core rule is that you must have been physically present in Canada for at least 730 days (two years) within the past five years.

There are a few exceptions to this rule, which may include:

- Traveling with a Canadian citizen spouse, common-law partner, or parent.
- Working overseas for a Canadian business or the public service.
- Accompanying a permanent resident spouse or common-law partner who is working overseas for a Canadian company.

If you do not meet the 730-day requirement, your application may be refused, and you could lose your permanent resident status. It is strongly recommended that you calculate your days of presence carefully before submitting the **Imm 5444 E** form. You can use the physical presence calculator

provided by Immigration, Refugees and Citizenship Canada (IRCC) to assist with this.

## **STEP-BY-STEP GUIDE TO COMPLETING THE IMM 5444 E**

---

Filling out the **Imm 5444 E application for a Permanent Resident Card** requires attention to detail. Mistakes or missing information can lead to processing delays or outright rejection. Here is a breakdown of each section of the form.

## **Section A:**

## Personal Details

This section requires your full legal name, date of birth, gender, and country of birth. It is critical that this information matches your passport and other immigration documents exactly. If you have a hyphen, accent, or a space in your name, include it precisely as shown on your official documents. You will also provide your current residential address and your mailing address if it differs from your home address. IRCC will send your new card to the mailing address you provide, so ensure it is reliable.

## Section B: Immigration History

Here, you will provide details about your most recent landing in Canada. This includes the date you became a permanent resident, the last Port of Entry (POE) you used, and your Unique Client Identifier (UCI) number. Your UCI is an eight- or ten-digit number found on your COPR or previous PR card. You will also list all of the countries you have visited or lived in during the past five years. Be as accurate as possible regarding dates and durations.

## Section C: Residency Obligation

This is the most important part of the **Imm 5444 E** form. You must account for every day of the past five years. You will list your absences from Canada, including the reason for each trip. For extended absences, you may need to provide additional proof, such as employment records or school transcripts. If you are applying for a renewal, you must demonstrate that you have met the 730-day physical presence requirement.

## Section D: Additional Information

This section asks questions about your criminal history, any previous immigration applications, and whether you have ever been asked to leave Canada. Answer all questions truthfully. Providing false information on the **Imm 5444 E application for a Permanent Resident Card** is considered misrepresentation and can result in a five-year ban from entering Canada.

## DOCUMENTS

A complete application package is more than just the **Imm 5444 E** form. You must include several supporting documents to prove your identity and residency. Failing to include these documents is one of the most common reasons for application returns.

1. **Photocopies of your current PR card (both sides):** Only required if you are renewing or replacing an existing card.
2. **Two identical passport-sized photos:** These must meet IRCC's strict photo specifications. Photos that are too small, too large, or taken in poor lighting will be rejected.

## REQUIRED SUPPORTING DOCUMENTS

3. **Photocopy of your valid passport or travel document:** This must include all pages containing your photo, personal details, and any entry/exit stamps from the past five years.
4. **Proof of residency:** This can include pay stubs, tax assessments (Notice of Assessment from the Canada Revenue Agency), rental agreements, utility bills, or school records. These documents help prove that you physically lived in Canada.
5. **Additional documents for specific situations:** If you were outside of Canada for an extended period due to employment or family reasons, you may need a

letter from your employer or proof of your family member's status in Canada.

## Photo Specifications: A Common Pitfall

Many applications are delayed because of improper photos. The photos must be 50 mm wide by 70 mm high. The face must be centered, with the head measuring between 31 mm and 36 mm from chin to crown. The background must be plain white or light gray. Do not wear glasses unless they are a medical necessity, and ensure the photo is not

edited or filtered. Write the studio's name, address, and the date the photo was taken on the back of one photo. The photographer's stamp is required.

### HOW TO SUBMIT YOUR IMM 5444 E APPLICATION

---

Once you have completed the **Imm 5444 E application for a Permanent Resident Card** and gathered all supporting documents, you have two submission options, though the default method has changed in recent years.

#### **Option 1: Application by Mail**

Until recently, most PR card applications were submitted through a physical application by mail. You would place your **Imm 5444 E** form, photos, and documents in a secure envelope and send it to the Case Processing Centre in



Sydney, Nova Scotia. However, IRCC has been transitioning to a digital system.

### **Option 2: Online Application via the PR Portal**

As of recent updates, most new permanent residents and applicants for card renewal are now required to use the Permanent Resident Portal. This is a secure online platform where you can upload your **Imm 5444 E** form, pay your fees, and submit your photos digitally. This method is generally faster and provides better tracking. You will receive an invitation to the portal after your landing interview, or you can request access if you are renewing.

It is vital to check the official IRCC website to confirm which method is currently active. Using the wrong method could result in your application

being returned unprocessed.

---

## **PROCESSING TIMES AND FEES**

---

Patience is a virtue when dealing with PR card applications. The processing time for a new or renewed Permanent Resident Card is typically between 60 and 100 days, though this can vary based on the complexity of your file and the current volume of applications. Replacing a lost or stolen card may take longer due to the additional security checks involved.

The current processing fee for a Permanent Resident Card application is \$50 CAD. This fee is non-refundable, even if your application is refused. You can pay online through the IRCC official payment portal. You will need to print the receipt and include it with your

application (or upload it if applying online).

## COMMON MISTAKES TO AVOID

---

To ensure your **Imm 5444 E application for a Permanent Resident Card** proceeds smoothly, avoid these common errors:

- **Using an outdated form:** Always download the latest version of the **Imm 5444 E** from the IRCC website. Using an old version will result in an automatic return.
- **Incomplete information:** Do not leave any fields blank. If a section does not apply to you, write "N/A" (Not Applicable).
- **Incorrect dates:** Double-check your travel dates against your

passport stamps. A discrepancy of even one day can raise red flags.

After you submit your **Imm 5444 E** application, you will receive an acknowledgment of receipt from IRCC.
