Summarize why your team or organization is uniquely positioned to deliver these results. Highlight relevant experience, case studies, or credentials that build trust.

Call to

Action

End with a clear statement of what you want the reader to do next—whether that is approving the proposal, scheduling a meeting, or moving to contract discussions.
