UNDERSTANDING THE FRUIT OF THE POISONED TREE DOCTRINE IN CRIMINAL LAW

Under this arrangement, federal prosecutors could use evidence illegally obtained by state law enforcement officers, as long as federal officers had not participated in the illegal conduct. HOW THE DOCTRINE WORKS IN PRACTICE

KEY EXCEPTIONS TO THE DOCTRINE

For example, if a

suspect is illegally arrested but later released, and then voluntarily returns to the police station to confess weeks later, the confession may be admissible if the connection to the illegal arrest has been attenuated.

Good Faith Exception

Although originally developed in the context of the exclusionary rule rather than the **Fruit of a Poisoned Tree** doctrine itself, the good faith exception has important implications. Under *United States v. Leon* (1984), evidence obtained by police acting in reasonable reliance on a search warrant that is later found to be invalid may still be admissible. The rationale is that excluding evidence does not deter police misconduct when the officers believed they were acting lawfully.
