The trial of Arne Cheyenne Johnson took place in Danbury, Connecticut, in 1981, and drew intense national and international scrutiny. Judge Robert Callahan ultimately ruled that the defense could not present evidence of demonic possession because it failed to meet the legal standards of credibility. ### ED AND LORRAINE WARREN

No discussion of The Devil In Connecticut is complete without examining the role of Ed and Lorraine Warren. The couple had already gained fame for their work on the Amityville and Perron cases. ### DEBBIE GLATZEL AND ARNE JOHNSON

Debbie Glatzel, David's sister and Arne Johnson's fiancée, maintained that the possession and the subsequent demonic transfer were real. Johnson himself has remained relatively private since his release but has on occasion indicated that he believes something supernatural occurred, though he has not given a full public account.

Notably, many researchers and writers have cast doubt on the authenticity of The Devil In Connecticut case. Skeptics point to several inconsistencies:
