Once you have chosen a structure, you will need to register your business name with your state and local government. You may also need to obtain an Employer Identification Number (EIN) from the IRS, even if you do not have employees. Additionally, check with your city or county about required business licenses,

permits, and zoning regulations. A home-based bakery, for example, will have different health code requirements than a brick-and-mortar restaurant.

STEP 4: SECURE FUNDING FOR YOUR LOCAL VENTURE
