Unlike competitors, our system is fully automated, includes a mobile app for monitoring plant health, and uses 90% less water than soil-based gardening. GreenSprout is registered as a Delaware C-Corp.

Market Analysis

The indoor gardening market has experienced rapid growth, driven by increasing consumer interest in organic food, sustainability, and self-sufficiency. Our primary target market includes urban residents aged 25 to 40 living in apartments of 800 square feet or less. Secondary markets include schools, restaurants, and corporate wellness programs. Funding Request

GreenSprout is seeking \$500,000 in seed funding. The funds will be allocated as follows: \$200,000 for final product development and tooling, \$150,000 for marketing and launch campaign, \$100,000 for initial inventory and fulfillment setup, and \$50,000 for operational expenses including legal, accounting, and software subscriptions. Financial Projections
