STEP 4: APPOINT A REGISTERED AGENT

Most states require you to designate a registered agent—a person or company authorized to receive legal documents on behalf of your business. The agent must have a physical street address in the state and be available during normal business hours. You can serve as your own registered agent, but many entrepreneurs hire a professional service for privacy and convenience. This is an often overlooked but essential part of understanding **how to register a business** correctly.

STEP 5: OBTAIN AN

IDENTIFICATION NUMBER (EIN)

An EIN (also known as a Federal Tax Identification Number) is issued by the IRS and used to identify your business for tax purposes.
