PROVIDER AND PRACTICE DETAILS

The top portion of the form should clearly display your practice name, address, phone number, and tax ID. PATIENT DEMOGRAPHICS AND INSURANCE INFORMATION

DIAGNOSIS AND PROCEDURE CODES

This is where clinical precision matters most. Use the most specific ICD-10 codes available to describe the patient's condition. For example, instead of using a general code for back pain, use a code that specifies the exact region of the spine affected. Similarly, CPT codes must reflect the precise services performed, such as spinal manipulation, therapeutic exercises, or electrical stimulation.

Common CPT codes used in chiropractic include:

- **98940** – Chiropractic manipulative treatment (CMT), spinal, 1-2 regions

- **98941** – CMT, spinal, 3-4 regions
- **98942** – CMT, spinal, 5 regions
- **97110** – Therapeutic exercises
- **97035** – Ultrasound therapy

Each code should be accompanied by the appropriate modifier if applicable. Modifiers indicate special circumstances, such as when a service was performed on both sides of the body or when a procedure was reduced in scope.

DATE OF SERVICE AND PLACE OF SERVICE CODES

Every entry on the superbill must include the date the service was provided. Place of service codes indicate where the treatment occurred, such as an office (11) or the patient's home (12). Using the correct place of service code is critical because some insurance plans pay different rates based on the setting.

FINANCIAL SUMMARY

A clear breakdown of charges helps patients understand what they owe and what they can expect from their insurance company. List each procedure code, its description, the fee charged, and any payments already made. The total amount should be easy to identify.

PROVIDER SIGNATURE AND CREDENTIALS

Insurance companies require proof that a licensed professional provided the services. Your signature, along with your license number and a stamp or printed name, authenticates the superbill. Some payers are increasingly strict about electronic signatures, so ensure your digital signature process meets their standards.

Common Mistakes to Avoid When Using Chiropractic Superbill Forms
